Membership Requirements

- The private studio or school music teacher of the student soloist or small ensemble entering the Solo and Ensemble Festival must be a current member of NAFME (formerly MENC) with a membership that does not expire before the event.

Entry Categories and Requirements

- Solo entries are welcome for standard band and orchestral instruments, voice, classical guitar and piano.
- Small ensemble entries are welcome for chamber music ensembles consisting of instruments from the above categories.
- There is a maximum of 15 performers per ensemble group.
- Music performed should be in the art music tradition. Jazz, Pop and Broadway Show music is not accepted.
- Live accompaniment is preferred, but not required. Recorded accompaniment is allowed at this festival, however live music is required at the state festival.

Length of Performance

- Solos may not exceed 10 minutes in performance length.
- Small ensemble performances may not exceed 14 minutes in performance length.

Payment Information

- Fees: Solo Performer = \$20.00 / Ensemble (Two or more performers) = \$15.00 each
- Send registration with fees enclosed to the address on the bottom of the registration form.
